Whether you are entitled to maintenance for yourself depends on a number of factors - how long you have been married, whether you have children who will receive maintenance and your future earning capacity are important, but all your circumstances will be taken into account. There may also be other issues to consider such as the family home or the family business. It is important to seek advice to find out about your options.

In England and Wales, living together as a “common law” husband and wife has no legal status.

No matter how long you have lived together, there are no legal rights to maintenance for yourself. You may be entitled to child maintenance if there are children from your relationship. What will happen to your property and other assets depends on many factors.
