our commercial approach

We encourage clients to use our services as an extension of their own credit control procedures acting as soon as the debt becomes overdue.

Each case is allocated to a case worker at the appropriate level under the direct supervision of a partner. Each case worker has a thorough understanding of the entire debt collection process from initial instructions through to Judgment and enforcement.

We will advise you on cost, timescale and potential risks so that you can make informed and commercial decisions on the recoverability of the debt.

undefended debts

In the majority of cases a solicitor's letter making formal demand for payment within 7 days will prompt immediate payment. The cost for this is £10 plus vat.

In the event of non payment after the expiry of the 7 day letter of demand a Claim Form and Particulars of Claim will be issued in the County Court against the debtor. The Court fee and fixed recoverable costs and statutory interest will be added to the debt. We will promptly enforce Judgment against the debtor by instructing the High Court Enforcement Officer. Alternatively we will advise you on the appropriate enforcement strategy to secure payment. Enforcement options are detailed on our website.

defended debts

If the Claim becomes defended the matter will be referred to a Solicitor in the dispute resolution department. At this stage we can then advise you on the legal issues, litigation risk and the costs involved in defended litigation. At this time an alternative fee structure will be put in place.
